

TOWN OF STOCKBRIDGE  
CALUMET COUNTY, WISCONSIN

AN ORDINANCE ESTABLISHING STOP SIGNS AND YIELD SIGNS ON TOWN ROADS IN THE TOWN OF STOCKBRIDGE, CALUMET COUNTY, WISCONSIN.

WHEREAS, the Town Board of the Town of Stockbridge deems it necessary for public safety within the Town to regulate, by stop sign or yield sign, certain intersections of town roads within the Town, and by virtue of the authority granted under Section 349.07 of the Wisconsin Statutes;

BE IT ORDAINED by the Town of Stockbridge, Calumet County, Wisconsin, as follows:

Section 1. STOP SIGNS. Every operator of a vehicle approaching an official stop sign shall stop in the manner prescribed by Section 346.46 of the Wisconsin Statutes.

Section 2. STOP SIGNS ENUMERATED. Stop signs shall be placed at the following locations to control the movement of vehicles on the following Town of Stockbridge roadways:

1. Traveling North at the Southeast corner of the intersection of Fairy Springs Road and Faro Springs Road.
2. Traveling North at the Southeast corner of the intersection of Lake Shore Drive and Faro Springs Road.
3. Traveling North at the Southeast corner of the intersection of Moehn Road and Faro Springs Road.
4. Traveling North at the Southeast corner of the intersection of Long Road and Faro Springs Road.
5. Traveling North at the Southeast corner of the intersection of Vans Road and Faro Springs Road.
6. Traveling South at the Northwest corner of the intersection of Moehn Road and Carney Road.
7. Traveling West at the Northeast corner of the intersection of Carney Road and Long Road.
8. Traveling North at the Southeast corner of the intersection of Moehn Road and Carney Road.
9. Traveling East at the Southwest corner of the intersection of Carney Road and Long Road.

10. Traveling South at the Northwest corner of the intersection of Moehn Road and Hill Road.
11. Traveling South at the Northwest corner of the intersection of Cordy Road and Hill Road.
12. Traveling West at the Northeast corner of the intersection of Hill Road and Long Road.
13. Traveling North at the Southeast corner of the intersection of Moehn Road and Hill Road.
14. Traveling North at the Southeast corner of the intersection of Cordy Road and Hill Road.
15. Traveling East at the Southwest corner of the intersection of Hill Road and Long Road.
16. Traveling East at the Southwest corner of the intersection of Hill Road and Vans Road.
17. Traveling West at the Northeast corner of the intersection of Maple View Lane and Lake Shore Drive.
18. Traveling West at the Northeast corner of the intersection of Moore Road and Lake Shore Drive.
19. Traveling South at the Northwest corner of the intersection of Cordy Road and Moore Road.
20. Traveling West at the Northeast corner of the intersection of Moore Road and Long Road.
21. Traveling East at the Southwest corner of the intersection of Moore Road and Long Road.
22. Traveling West at the Northeast corner of the intersection of Hickory Hills Road and Long Road.
23. Traveling East at the Southwest corner of the intersection of Hickory Hills Road and Long Road.
24. Traveling Northwest at the Southeast by East corner of the intersection of Shady Lane and Hickory Hills Road.
25. Traveling Southeast at the Southwest by West corner of the intersection of Shady Lane and Long Road.
26. Traveling East at the Southwest corner of the intersection of Ledge Road and Moehrke Road.
27. Traveling West at the Northeast corner of the intersection of Mud Creek Road and Lake Shore Drive.
28. Traveling East at the Southwest corner of the intersection of Mud Creek Road and Lake Shore Drive.
29. Traveling West at the Northeast corner of the intersection of Artesian Road and Lake Shore Drive.
30. Traveling East at the Southwest corner of the intersection of Twilight Beach Road and Lake Shore Drive.

31. Traveling West at the Northeast corner of the intersection of Joe Road and Lake Shore Drive.
32. Traveling West at the Northeast corner of the intersection of Court Road and Long Road.
33. Traveling South at the Northwest corner of the intersection of Long Road and Quinney Road.
34. Traveling North at the Southeast corner of the intersection of Long Road and Quinney Road.
35. Traveling West at the Northeast corner of the intersection of Schluchter Road and North Tower Road.
36. Traveling West at the Northeast corner of the intersection of Quinney Road and Lake Shore Drive.
37. Traveling East at the Southwest corner of the intersection of Quinney Road and Lake Shore Drive.
38. Traveling North at the Southeast corner of the intersection of East Winn Road and Quinney Road.
39. Traveling South at the Northwest corner of the intersection of Konsin Beach Road and Quinney Road.
40. Traveling West at the Northeast corner of the intersection of Ecker Lakeland Drive and Lake Shore Drive.
41. Traveling East at the Southwest corner of the intersection of Ecker Lakeland Drive and Lake Shore Drive.

Section 3. YIELD SIGNS. Every operator of a vehicle approaching an official yield sign shall yield in the manner prescribed by Section 346.18(6) of the Wisconsin Statutes.

Section 4. YIELD SIGNS ENUMERATED. Yield signs shall be placed at the following locations to control the movement of vehicles on the following Town of Stockbridge roadways:

1. Traveling North at the Southeast corner of the intersection of Cordy Road and Carney Road.
2. Traveling East at the Southwest corner of the intersection of Carney Road and Vans Road.
3. Traveling West at the Northeast corner of the intersection of Campbell Drive and Maple View Lane.
4. Traveling North at the Southeast corner of the intersection of Mayflower Lane and Hill Road.
5. Traveling South at the Northwest corner of the intersection of Moehn Road and Moore Road.
6. Traveling South at the Northwest corner of the intersection of Mayflower Lane and Moore Road.

7. Traveling North at the Southeast corner of the intersection of Moehrke Road and Hickory Hills Road.
8. Traveling North at the Southeast by South corner of the intersection of Long Road and Shady Lane.
9. Traveling West at the Northeast corner of the intersection of Quinney Road and North Tower Road.
10. Traveling East at the Southwest corner of the intersection of Quinney Road and Minahan Road.
11. Traveling East at the Southwest corner of the intersection of Quinney Road and North Tower Road.

Section 5. AUTHORIZATION. The proper Town Officers are hereby authorized and directed to install official stop and yield signs on the above enumerated Town of Stockbridge roadways indicating such requirement.

Section 6. PENALTIES.

1. Any person violating any provision of Section 1 of this Ordinance may be fined not less than \$20.00 nor more than \$40.00 for the first offense and not less than \$50.00 nor more than \$100.00 for the second or subsequent conviction within a year.

2. Any person violating any provision of Section 3 of this Ordinance may be fined not less than \$20.00 nor more than \$50.00 for the first offense and not less than \$50.00 nor more than \$100.00 for the second or subsequent conviction within a year.

Section 7. REPEALER. Any Ordinance not wholly in conformity with this Ordinance and contradictory thereto is hereby expressly repealed. Specifically, that Ordinance adopted by the Town Board of the Town of Stockbridge on August 2, 1957 providing for stop signs at certain intersections is hereby repealed.

Section 8. EFFECTIVE DATE. This Ordinance shall be in full force and in effect from and after its adoption and publication as required by law.

This Ordinance was passed by the unanimous vote of the Town Board of Supervisors at the meeting of said Town Board of the Town of Stockbridge, Calumet County, Wisconsin, held at the Town Hall, on the 1st day of May, 1985.
