Monthly Town Board Minutes  
7:00 p.m. Wednesday, October 7, 2015  
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Treasurer Ralph Schmid, Clerk Janene Van Hoorn, and Road Supervisor Jerry Ortlieb.

The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Jeff Yelton made a motion to approve the agenda. Seconded by Connie Loewe. Motion Carried.

Public Comment: None

Jeff Yelton made a motion to approve the September 10, 2015 meeting minutes as printed. Seconded by Connie Loewe. Motion Carried.

Town roads, equipment and buildings discussion: Ortlieb updated the board on roads and equipment. Ortlieb updated the board on the sewer line and the parking lot for the Stockbridge Community Hall/Fire Department. The town submitted a project for LRIP funds. LRIP Funds were awarded to Towns of Rantoul and Brillion. Ortlieb and Schaefer met with the DNR regarding Artesian Road. The town will complete a final permit on section 4 and 5 according to DNR records.

Discussion on the Ordinance for Restricting Use and Obstructing of Ditches and Embankments of Town Roads ordinance permit and fee schedule occurred. The board will contact Attorney McDermott about developing a permit/fee/escrow schedule.

Discussion/possible action on recycling program: Discussion on the merits of our contract with Advanced Disposal occurred. Schaefer made a motion to obtain single stream recycling containers provided by Advanced Disposal. Seconded by Connie Loewe. Roll Call Vote. Schaefer Aye, Loewe Aye. Yelton Abstain. Motion Carried.

Discussion/possible action on Fire Department and First Responder budgets: The budgets were reviewed.

Correspondence/Communications: Communications were reviewed.

The Treasurer's Report was presented. Jeff Yelton made a motion to accept the Treasurer's report. Seconded by Connie Loewe. Motion Carried.

Jeff Yelton made a motion to approve and pay the bills as presented to the board. Seconded by Connie Loewe. Motion Carried.

The board set the preliminary budget work meeting for October 22, 2015 at 7 p.m. The Budget Hearing and Special Town Meeting will be held on Nov. 11, 2015 at 6:30 p.m.

Schaefer made a motion to adjourn the town meeting with possible reconvening to open session after the closed session. Seconded by Connie Loewe. Motion Carried.

Schaefer made a motion to enter into closed session under Wis. Statute 19.85 (1) (e) to discuss a claim for damages regarding the Quinney Road boat landing. Seconded by Connie Loewe. Roll Call Vote: Schaefer Aye, Yelton Aye, Loewe Aye. Motion Carried.

Schaefer made a motion to reconvene into open session. Seconded by Connie Loewe. Motion Carried.

Being no further business Connie Loewe made a motion to adjourn. 2<sup>nd</sup> by Jeff Yelton. Meeting adjourned 8:15 p.m.
