Monthly Town Board Minutes
7:00 p.m. Wednesday, August 10, 2016
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Treasurer Ralph Schmid, Clerk Janene Van Hoorn, Road Supervisor Jerry Ortlieb, Stockbridge Fire Chief Michael Funk and three town residents.

The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Jeff Yelton made a motion to approve the agenda. Seconded by Connie Loewe. Motion Carried.

Town roads, equipment and buildings discussion: Ortlieb updated the board regarding the parking lot around the fire station and Community Hall. MCC will be addressing the issue this week and will contact Ortlieb with their proposal for a solution. Discussion on a masonry mailbox placed in the road right of way occurred. A letter will be sent to the resident regarding the regulations around road right of way and mailboxes. Ortlieb asked about handling of road kill deer. Jeff Yelton made a motion to adopt the endorsed Wisconsin Towns Association Just Fix It Resolution #2016-02. Seconded by Connie Loewe. Motion Carried.

Quinney Road culvert project pre construction work will begin shortly. The Mud Creek Road bridge project is currently under construction.

The clerk presented an application for a Class B Beer and Liquor Retailer's License for Dale VandenBloomer DBA as Fish Tail Inn. Connie Loewe made a motion to approve a Class B Beer and Liquor Retailer's License for Dale VandenBloomer as presented pending his submittal of a State of Wisconsin Sellers Permit number and Federal Employer Identification number. Seconded by Jeff Yelton. Motion Carried.

Correspondence/Communications: Communications were reviewed. Schaefer had an email regarding handling of yard waste. Ortlieb related the problems which occurred when the town previously had a spot for yard waste. The clerk updated the board on the August 9, 2016 election and upcoming issues with the Nov. 8, 2016 election.

The Treasurer's Report was presented. Jeff Yelton made a motion to accept the Treasurer's report as presented. Seconded by Connie Loewe. Motion Carried.

Jeff Yelton made a motion to approve and pay the bills as presented to the board. Seconded by Connie Loewe. Motion Carried.
