Monthly Town Board Minutes
7:00 p.m. Wednesday, October 19, 2016
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Treasurer Ralph Schmid, Clerk Janene Van Hoorn, Road Supervisor Jerry Ortlieb, and three town residents.

The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Jeff Yelton made a motion to approve the agenda. Seconded by Connie Loewe. Motion Carried.

Public Comment: None

Jeff Yelton made a motion to approve the September 14, 2016 meeting minutes as printed. Seconded by Connie Loewe. Motion Carried.

Town roads, equipment and buildings discussion: Ortlieb updated the board regarding the ditch cutting, work for the village, snow equipment preparation and supplies. The parking lot paving issues around the Community Hall/Fire Station were discussed. A letter was received from MCC stating they will make good or repair the whole or any part of the work within 3 years after the date of acceptance of the completed work which failed in its performance. Schaefer offered an update on the Quinney Road boat landing issue. Schaefer met with the attorney regarding the small claims court action and the board discussed further actions. Problems with mud on the roads was discussed.

The Quinney Road culvert project is done with the exception of paving. The Mud Creek Road bridge project is ready to be paved.

Fire Department and First Responder budgets were discussed. Jeff Yelton made a motion to approve the 2017 Fire Department Budget. Seconded by Connie Loewe. Motion Carried. Ken Schaefer made a motion to approve the 2017 First Responder Budget. Seconded by Jeff Yelton. Roll Call Vote: Schaefer Aye, Yelton Aye, Loewe Abstain. Motion Carried.

The budget work meeting was set for October 26, 2016 at 6:30 p.m. The Budget Hearing/Special Town Meeting was for November 9, 2016 at 7:00 p.m.

The voiced no objections to the Certified Survey for Arthur Reif.

Correspondence/Communications: Communications were reviewed.

The Treasurer's Report was presented. Jeff Yelton made a motion to accept the Treasurer's report as presented. Seconded by Connie Loewe. Motion Carried.

Jeff Yelton made a motion to approve and pay the bills as presented to the board. Seconded by Connie Loewe. Motion Carried.

Being no further business Connie Loewe made a motion to adjourn. 2nd by Ken Schaefer. Meeting adjourned 7:46 p.m.
