Monthly Town Board Minutes
7:00 p.m. Thursday, September 21, 2017
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Clerk Janene Van Hoorn, County Board Supervisor Judy Hartl, Nick VandeHey of McMahon, Jim Baumhardt of Baumhardt Sand and Gravel and one guest. Absent: Treasurer Ralph Schmid and Town Road Supervisor Jerry Ortlieb.

The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Schaefer made a motion to place Agenda Item number 9 directly after Agenda Item number 5. Seconded by Jeff Yelton. Motion Carried. Jeff Yelton made a motion to approve the agenda with the modification. Seconded by Connie Loewe. Motion Carried.

Public Comment: Judy Hartl appeared before the board to explain her vote regarding the county sales tax. Gary Ricker, a village resident, appeared regarding speed limit signs north of the village limits and requested that the 35 mph speed limit extend approximately 1000 feet north. Ricker requested that the town send a letter of support to the Wis. Department of Transportation for the change.

Update on Mud Creek Bridge project: The project has been postponed until the first week of October.

Connie Loewe made a motion to approve the August meeting minutes as printed. Seconded by Jeff Yelton. Motion Carried.

Town roads, equipment and buildings discussion: Ken Schaefer updated the board on town work. Roadside cutting has been completed and a rental boom mower will be arriving in October.

The discussion on the Fire Station/Community Hall parking lot occurred. Jeff Yelton made a motion that the top coat of the parking lot should be ground and re-laid. Seconded by Connie Loewe. Motion Carried.

Review of First Responder and Fire Department proposed 2018 budgets. The First Responders have 5 new members with additional cost for LOSAP. Ken Schaefer made a motion to approve the First Responder budget. Seconded by Jeff Yelton. Roll call vote: Schaefer yes, Yelton yes, Loewe abstain. Motion Carried. Jeff Yelton made a motion to approve the Fire Department Budget. Seconded by Connie Loewe. Motion Carried.

The Board voiced no objection to Certified Survey Maps for Kenneth Tasch and for Robert Head.

Due to a conflict with building usage the October meeting was changed to Tuesday, October 10, 2017 at 7 p.m.

Correspondence/Communications: Communications were reviewed.

The Treasurer's Report was presented. Connie Loewe made a motion to accept the Treasurer's report as presented. Seconded by Jeff Yelton. Motion Carried.

Jeff Yelton made a motion to approve and pay the bills as presented to the board. Seconded by Connie Loewe. Motion Carried.

Being no further business, Jeff Yelton made a motion to adjourn. 2nd by Connie Loewe. Meeting adjourned 8:30 p.m.
