Monthly Town Board Minutes  
7:00 p.m. Wednesday, June 10, 2015  
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Treasurer Ralph Schmid, Clerk Janene Van Hoorn, Road Supervisor Jerry Ortlieb, and 9 town residents and guests. The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Jeff Yelton made a motion to approve the agenda. Seconded by Connie Loewe. Motion Carried.

Public Comment: None

Connie Loewe made a motion to approve the May 13, 2015 meeting minutes as printed. Seconded by Ken Schaefer. Motion Carried.

Town roads, equipment and buildings discussion: Ortlieb updated the board on roads and equipment. The new plow truck was delivered. Discussion on town logo for the truck occurred. Ortlieb has removed a dead tree at Fairy Springs and is cutting road sides. Schaefer brought up management of the bridge projects for next year. Two proposals for blacktop have been received for the Fire Station/Community Hall parking lot-Northeast Asphalt bid price is \$80,465.00 and MCC bid price is \$65,444.07. Jeff Yelton made a motion to proceed with the paving of the parking lot and to accept the MCC bid. Seconded by Connie Loewe. Motion Carried.

Discussion/possible action on Quinney Road damage at boat landing: Schaefer updated the board on issues with indentations in the pavement and discussions he had with the hauler and with Walleyes for Tomorrow regarding damages at the boat landing.

Review of Liquor/Beer/Wine/Temporary Beer License Applications. The clerk presented the applications received. Ken Schaefer made a motion to approve a Temporary Class B Retailer's License to Brickyard Fishing Club, Class B Beer and Class B Liquor Licenses to Dwayne Nushardt DBA Fishtale Inn Food-n-Spirits, Hansen Cattle Co. LLC DBA Hansen's Kloten Oasis, Paul Schneider DBA Quinney Quencher, Marcia Klein DBA MAK's Shanty contingent upon no objections being received within the 15 day time period after publication, Boerger Properties, LLC DBA Lakeview Campground, Class B Beer to Winnebago Eastshore Conservation Club, Special Class B Winery License to Edward Rink DBA Quinney Estate Winery LLC and Operator's Licenses to Randall Klein, Leslie Kerklin, Kasey Lueck, Ruth Geiser, Tina Wunrow, Victoria Schneider, Mary Schneider, Lisa Manz, Thomas Woelfel, Thomas Schwobe, Ted Sell, Robert Reif, Thomas Roberts and Don Kemps.

The board voiced no objection to the certified survey map for Leo Van Hoorn.

Correspondence/Communications: Yelton received an email from Calumet County Planning and Zoning stating there is no record of a DNR permit issued in the early to mid-1990's for Artesian Road in a priority watershed project.
