Monthly Town Board Minutes
7:00 p.m. Wednesday, November 11, 2015
Stockbridge Community Hall

Chairman Ken Schaefer called the meeting to order at 7:00 p.m. Present were Supervisor Connie Loewe, Supervisor Jeff Yelton, Treasurer Ralph Schmid, Clerk Janene Van Hoorn, Road Supervisor Jerry Ortlieb, Calumet County Storm and Erosion Control Specialist Brent Jalonen, Calumet County Conservationist Tony Reali, Rob Ash representing Wisconsin Public Service and seven town residents and guests.

The Pledge of Allegiance was recited.

The Clerk verified that notices were posted.

Jeff Yelton made a motion to approve the agenda. Seconded by Connie Loewe. Motion Carried.

Public Comment: None

Jeff Yelton made a motion to approve the October 7, October 22 and November 4, 2015 meeting minutes as printed. Seconded by Connie Loewe. Motion Carried.

Brent Jalonen introduced himself and explained his duties as in the new position of Storm and Erosion Control Specialist for Calumet County. Jeff Yelton and Ken Schaefer explained the unique reoccurring situation regarding storm water management in the town due to the Niagara Escarpment and Lake Winnebago. Discussion of Jalonen and Reali attending a future board meeting occurred.

Discussion with Rob Ash, representing Wisconsin Public Service, on a proposed project in the town occurred. Ash had questions regarding some permit requirements. Pole placement within the project was discussed.

Town roads, equipment and buildings discussion: Ortlieb updated the board on roads and equipment. Ortlieb updated the board on the completion of the parking lot paving for the Stockbridge Community Hall/Fire Department. A complaint was received about grass clippings being deposited in the town ditch on Lakeshore Drive. The Clerk was instructed to compose a letter addressing the situation.

Jeff Yelton made a motion to adopt the 2016 Town of Stockbridge Budget. Seconded by Connie Loewe. Motion Carried.

Discussion on garbage/recycling pickup on a private beach road, due to a resident complaining to an Advanced Disposal truck driver about the truck being driven on the road, was discussed. A letter was received from the Harsch's Beach Road Association stating that the association wishes to continue garbage/recycling pickup on the beach road. The Clerk was instructed to compose a letter to Harsch's Beach Road Association regarding the issue.

Jeff Yelton made a motion to approve a Temporary Class B Retailer's License to Woman's Life Insurance Society, Chapter 72 WI for an event at Critter Sitters Holiday Open House on December 13, 2015 from 1 p.m. until 4 p.m. Seconded by Connie Loewe. Motion Carried.

Correspondence/Communications: Communications were reviewed.

The Treasurer's Report was presented. Jeff Yelton made a motion to accept the Treasurer's report. Seconded by Connie Loewe. Motion Carried.

Jeff Yelton made a motion to approve and pay the bills as presented to the board. Seconded by Connie Loewe. Motion Carried.

Schaefer updated the board on the Quinney Road boating landing. The attorney has composed and sent letters.

Being no further business Connie Loewe made a motion to adjourn. 2nd by Jeff Yelton. Meeting adjourned 8:04p.m.
